Certificate of Quality

1. The concrete is furnished according to the Purchaser's specifications and water is added at the job site only at the purchaser's request.
2. Unloading time allowed is six minutes per cubic yard. Excess time is subject to charge.
3. Buyer acknowledges that concrete requires proper and adequate handling, placing, finishing, curing and protection after delivery and buyer agrees that the responsibility of Grundy County Redi-Mix Co., ceases immediately upon delivery.
4. Purchaser agrees to pay for towing service and repairs to the producer's equipment when unsatisfactory roads exist on the construction site.

The Purchaser agrees to provide suitable roadways or approaches to point of delivery beyond the curb line and on other than paved streets. We reserve the right to stop deliveries if the roadways or approaches are unsatisfactory to us. If the Purchaser requests delivery beyond the curb line or on other paved streets, Purchaser releases Grundy County Redi-Mix Co. from liability for and Purchaser will hold Grundy County Redi-Mix Co. harmless from and indemnify Grundy County Redi-Mix Co. against any liable damage to the curb, sidewalk or any property of contractor or owner or injury to any person whatsoever. If additional water or any other substances are added to the concrete at the job site by the Purchaser, or at his request, Grundy County Redi-Mix Co. is no longer responsible for slump, strength or quality of the concrete.

Purchaser or his authorized representative receipts for this load of concrete, confirms time of arrival, begins unload time, and has requested the driver to add water indicated.

This concrete contains correct water contents for strength indicated. We do not assume responsibility for test strength when water has been added at customer's request.

**Warning:** This product that you have purchased and are using may be harmful to your health, and physical well-being if not handled properly.
